

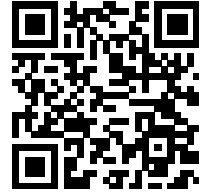

This means that if 1 kg of this refrigerant fluid would be leaked to the atmosphere, the impact on global warming would be 675 times higher than 1 kg of CO<sub>2</sub>, over a period of 100 years.
